The widely utilized waste management process requires separation of the tissue from the liquid, generally due to the medical waste provider not wanting the liquid with the tissue waste. OSHA Requirements and Employer Risk

Clean Harbors can help keep you in compliance by advising you of current state and federal waste regulations. If a hospital is working with formaldehyde solutions (an OSHA regulated material), the standard in 29CFR1910.1048 requires air sampling to ensure workers are not exposed to this chemical. There are numerous employer requirements including, employee training, respiratory programs, signage, exposure limits, testing, and employee notification of test results. Employers who do not follow these requirements are subject to fines. With the challenges and ever-changing demands healthcare facilities face managing their waste collection programs, most facilities don't follow the OSHA regulations required under 29CFR1910 for formaldehyde solutions as they aren't aware the regulations exist.

Local Sewer Board Approval

Almost all local sewer boards/publically owned treatment facilities require notification of chemical releases into the sewer. Few hospitals have articulated the release of formaldehyde solutions and the treatment chemical, and the timing and volumes of each. While local sewer entities are not searching for who is discharging these items, violators are subject to their jurisdiction to be fined for not disclosing the release of these materials.
