Eliminate Health & Safety Concerns (Formalin/Formaldehyde)

Neutralizing formalin solutions prior to disposal via the sanitary sewer can result in significant employee exposure to formaldehyde gas, which is suspected to be a human carcinogen by OSHA. Clean Harbors eliminates employee exposure to formaldehyde by omitting the need to separate formalin from tissue specimens. Our method enables employees to simply place containers of formalin with tissue specimens in drums and ship as is. This approach is cost-effective compared to other traditional approaches, which require additional steps including labor for pour-off and material for neutralizing the formalin.
