Since Clean Harbors' acquisition of Safety Kleen in December 2012, we now can manage in-house a larger variety of solvents in smaller quantities. In addition to managing tank truck quantities, we manage drum quantities. Not only do you benefit economically as well as maintain environmental stewardship by recycling your solvents, recycling might help your facility lower its status from a Large Quantity Generator to a Small Quantity Generator.

#### Lower Cost & Lower Risk Pathology Waste Option

Clean Harbors has the lower cost and lower risk solution to manage pathology wastes. Simply stated, we'll place tissue samples with formaldehyde solutions (still in the jar) in a drum and transport it for proper disposal. We understand that most pathology wastes have the tissue sample segregated from the formaldehyde solutions, usually because medical waste providers do not want to deal with the formaldehyde solutions. As a result, laboratory employees must manage the formaldehyde solutions in a manner that puts them and their employer at risk for non-compliance with OSHA regulations. In addition, most facilities are not aware of the requirements to notify the local sewer board of what is being poured down the drain. Clean Harbors can help keep you in compliance by advising you of current state and federal regulations.
